To Whom it May Concern,

The process for providing municipal appropriations to social service agencies changed in 2023 and we no longer utilize the petition warrant article process. The Town of Jaffrey changed the process in the effort to reduce the number of meetings and hearings the agencies are expected to attend (Budget Committee, Budget Committee Public Hearing, Town Meeting), reduce Town Meeting warrant articles, and provide an opportunity for the Select Board and Budget Committee to vet each agency request with the respective agency.

The 2024 funding process will proceed in the same manner:

- A completed funding application form must be submitted by the agency no later than the deadline of October 27, 2023. Agencies submitting late or incomplete funding applications will not be considered as part of the Municipal Funding Application Process (regardless of when their request to be considered and/or an application form was received).
- Regardless of previous history of funding or non-funding, an application will be required of all agencies seeking funding in a particular budget year, and each application and supporting financials will be reviewed carefully each year.
- All social service agency funding applications in their entirety will be presented to the Select Board's Social Services Budget Subcommittee.
- Representatives from all of the social service agencies requesting funding will be invited to attend a meeting with the Social Services Budget Subcommittee on November 8 or 9, 2023 to discuss their application and answer questions from committee members.
- The Social Services Budget Subcommittee will make an initial determination as to whether the agency is eligible for a municipal appropriation. If yes, Town staff will include the agency's funding request into the proposed municipal budget. If no, the request will not be factored into the proposed municipal budget presented to the Select Board.
- If the Budget Committee deems it necessary, the agency would be invited to attend their meeting on January 16, 2024. A remote meeting may be arranged for your convenience.

Social services appropriation requests should clearly demonstrate that the agency provides a critical service to Jaffrey residents that the Town would otherwise need to cover through either providing these services itself, or as a municipal welfare function. As a broad guideline, the municipal welfare function will be defined as providing the basic necessities of life that an individual, for whatever reason, is unable to pay for.

The Town of Jaffrey prohibits discrimination on the basis of race, color, national origin, sex, sexual orientation, religion, age, disability, marital or family status.

The Town of Jaffrey is an equal opportunity employer.

To demonstrate eligibility for a municipal appropriation from the Town of Jaffrey, requesting agencies will be required to address the following criteria as part of their application for funding:

1. The agency serves a core group of Jaffrey residents;
2. The agency provides a service that the Town of Jaffrey would otherwise be obligated to provide either directly as a Town service or would need to pay for through its municipal welfare function;
3. The services provided by the agency directly or indirectly reduce Town expenditures;
4. The agency must clearly demonstrate a financial need;
5. The services provided by the agency demonstrably enhance the quality of life in the Jaffrey community; and
6. Neighboring communities in the region are requested to provide funding to the agency on a basis similar to Jaffrey.

Enclosed you will find a Request for Funding for Social Agencies form. All requests for funding must either include this application completed by your key contact person, or must be in the form of a narrative that follows the same format.
